Each Internet connection has an IP address and when it is broadband or DSL this address is unique to the individuals account. This is how the police track pedophiles through the email that they write. In this case we found the IP address of the Munster letter and compared it to the IP address of a letter coming from Sherri Farmer. The address was identical. Since the Munster email was from a secondary source (Yahoo) there was no listing of the computer it was written from. However the email did emanate from the same Internet connection as other emails known to have be sent by Sherri Farmer .
